It has been observed that due Tax/es along with penalty, if any, in terms of the provisions of the under section 5/7/21/23 of Jharkhand Motor Vehicles Taxation Act 2001 and under rule 4/5 of Jharkhand Motor Vehicles Taxation Rules 2001 has not been paid by you after 09-Jun-2017 against the aforementioned vehicle.
