
1. Objective of Publishing this Book

Department has already made this book for official purpose. However, it is mainly required for driving learners to spread awareness among them about the Road, Traffic regulations and road safety. Keeping this in view, the Department wishes the book to be published and should be available in the market in all 24 districts of Jharkhand for people which will be useful for Jharkhand road users.


2. Scope of work

The Work is for Printing/Publication and Distribution of books in all over Jharkhand for drivers learners test and payment of royalty to Lead Agency (Road Safety), Dept. of Transport, Govt. of Jharkhand against the sale of book.

3. The book shall be printed in font size, font type, paper type, paper size, colour, binding quality etc as per the model book. The model book is available with the Department for inspection to ascertain these specifications. Bidders can take model from the premises of Department on any working day.
4. The published price of the book should be comparable to the price of similar book dealing with regulatory matters (CMVR, MV Act) etc.
5. The Publisher is free to publish as many copies as per demand. Publisher shall intimate the quantity to be printed in advance to Lead Agency (Road Safety) and all activities should be done at the cost of the Publisher-cum-Distributor and no payment will be done by Lead Agency (Road Safety)
6. The bidder has to create entire type setting, layout design and other necessary activities at its own cost. Dept. of Transport will not make any payment towards publishing and distribution of this book.
7. Before printing, book should be vetted by DoT, GoJ.
8. The entire responsibility of the publication will be of publishers except giving of model book.
9. Royalty per copy of book to be paid to the Lead Agency, Department of Transport has to be mentioned in financial bid.
10. Security money of Rs 50,000 (Rupees fifty thousand only) in the form of DD/BG Should be submitted to the department along with documents.
11. Technical Qualification of Printing/Publication-cum-Distribution Agency/Company
The following are technical qualifications:
 - a. The bidder should have experience of atleast three years experience in printing/publishing and distribution of books
 - b. The bidder have distribution agency in all 24 districts of Jharkhand. Copy of invoice may be submitted as proof for having distribution channel in every districts of Jharkhand.
 - c. If the bidder is printer, the bidder should have tie-up publishing agency for atleast three years for publishing and distribution network in Jharkhand.



- d. The publisher should submit PAN No and in case of printer, Factory License and EM-Part-II.
12. The technical bid and financial bid should be in two separate envelop and mentioned very clearly on the top of the envelop. These two envelops should be placed under one envelop and should be written on the envelop as " **Expression of Interest (EOI) from Printing/Publication and Distribution House/Agency/Company for a Book-"Question Bank for beginner Drivers learners test"**".
13. Last Date for the Submission of EOI will be 23rd November, 2020 at 4:00 PM at Joint Secretary (Road Safety), Dept. of Transport, FFB Building, Dhurwa, Ranchi.
14. DoT, GoJ will not be responsible for any misinterpretation or wrong assumption by the bidder, while responding to this EOI.
